

Program Policies, Terms & Conditions and Other Legal Terms

This document stipulates the Program Policy, the Privacy Policy and the Terms and Conditions of the Express Your Heart Method and this Website.

Program Policy

THE PROGRAM

Any program designed and delivered by Johanne Ascoli (Express Your Heart), whether a Women's Expressive Arts Circle, An Expressive Arts Program, Membership Circles, or any other program offered is here on end in this document referred to as a program or programs ("Program" | "Programs"). Programs designed and delivered by Johanne Ascoli (Express your heArt) are therapeutic expressive arts mentoring programs where the Program start date is defined as the agreed upon start date and where the Program end date is defined as the defined end date from the start date.

Upon purchasing a Program, the Client agrees to these Terms and Conditions and Program Policies.

PROGRAM REQUIREMENTS

In order for the client to fully enjoy and take advantage of the full benefits of the Program and its various components, the client will need the following, at a minimum:

- Oil Pastels (Mungyo oil pastels offer good price/quality) and whatever other arts materials you may wish to play and explore with (e.g., watercolours, felt markers, dry pastels, acrylic paints, magazine images, glue, scissors.) As well, tempera finger paints are highly recommended for the expressive arts session of Module 7 of the Express Your Heart pre-recorded Content Hub known as the “Express Your Heart Method and Heroine’s Journey”.
- Paper Pad / Art Journal / Sketchbook with blank pages and dimensions of at least 9x12 inches that supports multimedia (especially if you plan on using watercolours above and beyond the minimum requirement of oil pastels).
- Journal to write, reflect and journal.
- Space to move.
- Headphones and/or speakers.
- Spotify account if a Purchased Program contains access to the Express Your Heart pre-recorded Content Hub known as the “Express Your Heart Method and Heroine’s Journey”. Expressive arts sessions under Modules 7, 8, 9, 10 and 11 of that Content Hub offer playlists. Spotify tends to offer over

thirty minutes of ad-free listening experience every once in a while, if you watch a video advertisement. But, despite the offer, there have been instances where you are interrupted by an ad within fifteen minutes. However, Spotify offers a month-free trial of its Premium, ad-free account (after which, you will be billed \$9.99 CAD+tax per month). If you do not already have a Premium account and haven't yet used up your one-month free-trial, I would recommend signing up when you are ready to undertake Module 8's expressive arts session (Module 7 is a very short playlist that should not trigger any ads). Otherwise, a paid premium account is recommended to avoid being interrupted by Advertisements. Alternatively, if you have an Apple Music account, acquiring and lining up the songs on the Spotify playlists I offer may be a viable option to avoid interruptions.

PROGRAM FEES

All Program fees are subject to applicable taxes.

If the Client chooses the payment plan, they will be charged the initial payment at the time of enrolling, followed by installments every 30 days for the remaining weeks, on the same day of the month.

If the Client chooses the monthly payment plan, they are responsible for ensuring that their account remains in good standing for the entire duration of the Program. In most cases, payment will be automatically drawn from the initial method of payment used to register / purchase of Program.

If a payment is missed, the Client will have 5 business days to bring their account into good standing after the declined payment. If the account is not brought into good standing within 5 business days, the Client's Program will be put on hold and access will be denied until the account is brought into good standing. Extensions to the program completion time will not be offered as a result of program holds due to late or missed payments.

If the account remains in poor standing for a duration of more than 15 business days, the Client's Program will be canceled entirely, and no refund will be provided.

No refunds will be issued for the Program, including deposits or any partial Payments EXCEPT in specific agreed upon cases as stipulated in the Guarantee & Refunds section below.

GUARANTEE & REFUNDS

The Program is designed to support and assist you in reaching your own goals, but your success depends primarily on your own effort, motivation, commitment and follow-through. EXPRESS YOUR HEART cannot predict and does not guarantee that you will attain a particular result, and you accept and understand that results differ for each individual. Each individual's results depend on his or her unique background, dedication, desire, motivation, actions, and numerous other factors.

You fully agree that there are no guarantees as to the specific outcome or results you can expect from using the information you

receive on or through this Website, and through any Programs offered by Johanne Ascoli Express your heart.

You fully agree that no refunds of any kind will be issued for the Program, including deposits or any partial payments, except as follows:

A refund may be issued in cases where a basic membership paid in full is purchased and Johanne Ascoli (johanne@expressyourheart.com) is given 14 days advance written notice before the next 4-week period begins. A “month” herein always refers to a 4-week period. The first 4-week period of any membership program is non refundable, in full or partially. When conditions herein for termination are offered (i.e., 14 day written notice), refund for any subsequent paid membership period will be reimbursed at the sliding scale rate of purchase minus a \$25 (Canadian Dollars) administration fee.

Termination of memberships that include One to One (“1:1”) mentorship sessions may be refundable according to the same conditions stipulated in the previous paragraph. Any unused 1:1 sessions are also refundable at a cost of \$120 CAD each, inclusive of the next earliest scheduled 1:1 session if written notice is provided 48 hours prior to said next earliest 1:1 session.

LIMITED ACCESS

Access to the Express Your Heart Method & Heroine’s Journey Content Hub (the “Program Content Hub”) will be available to the client for the duration of the Program’s existence if the client pays

for “lifetime access”. Otherwise, access will be available for the duration of paid membership.

Access to the Community Facebook Group is revoked in the case of membership programs when membership is terminated.

Membership is terminated at the end of the period for which membership was paid. Weekly group expressive arts sessions and mentoring calls expire when membership is terminated. One to One (1:1) mentorship sessions expire when membership is terminated unless otherwise agreed to in writing before the end of the program.

CALL CANCELLATION / NO SHOW

One to One (“1:1”) calls/mentorship sessions (aka expressive arts sessions) purchased with any program must be canceled at least 48 hours prior to the scheduled call. In such cases where cancellation is not received within that time period and the client is a no show to the scheduled and mutually agreed upon time and date of the call, any rights to such call is forfeited, as well as any rights to any refunds for such call is forfeited.

CONFIDENTIALITY

The client understands that given the nature of the Program, including the

Facebook Group, that any discussions or any related Program discussions are to be

held in strict confidence and cannot be shared, referred to or mentioned outside of the designation Program Facebook Group.

EXPRESS YOUR HEART PRIVACY POLICIES

This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site. We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

WHAT IS CONSIDERED PERSONAL INFORMATION?

SENSITIVE DATA

We do not collect any Sensitive Data about you. We do not collect any information about criminal convictions and offences.

MARKETING COMMUNICATIONS

Our lawful ground of processing your personal data to send you marketing communications is either your consent or our legitimate interests (namely to grow our business).
